MINUTES OF A MEETING OF WHIPPINGHAM PARISH COUNCIL THAT WAS HELD AT 7.00PM ON THURSDAY 10^{TH} OCTOBER 2019 AT THE WHIPPINGHAM COMMUNITY CENTRE ALVERSTONE ROAD WHIPPINGHAM

To welcome Cllr Matthew Price as a co-opted member to the Council Meeting

The Chairman welcomed Matthew Price to the meeting as a co-opted Whippingham Councillor. The Meeting was informed that Cllr Price's Isle of Wight Council seat covers the part of the Parish that is at Island Harbour and that was where there was a vacancy for a Parish Councillor.

PRESENTATION/UPDATE BY NATURAL ENGLAND OFFICERS ON THE PROPOSED COASTAL PATH AT WHIPPINGHAM PRIOR TO THE COUNCIL MEETING COMMENCING

31 Local Residents were present to hear the presentation by Natural England Officers.

The Chairman welcomed the Natural England Officers to the meeting and asked them to give their presentation on the proposals for the Coastal Path.

The Officers informed the meeting it was an ongoing process that Natural England had been tasked to do. They are adapting the route and they do understand the frustrations that are being felt in Whippingham. They are trying to get the balance right. They reported that they could not go through Osborne and also the Registered Parks and Gardens. They are speaking to English Heritage as they don't want to be on the road.

The residents informed them in no uncertain terms that they had not told people nor talked to them about the various proposals. The residents felt very strongly that everyone should have been written to at the same time. Some people had still not received a letter notifying them of proposals that would affect them. It was felt that they were being picked off a few at a time and no one could see a whole picture.

People present raised the point time and time again that what was being proposed for Whippingham was not a coastal path as you cannot see the sea from any part of the various routes that had been put forward including going between two houses at The Height which leads to garages. Many people raised the question about their privacy being invaded and also the additional vulnerability of some of our elderly residents as well as the amount of farming land it would remove from cultivation.

The Officers informed the meeting that the Act of Parliament for the Coastal Path that had been passed meant that legally they had to produce a coastal path for the Island as near to the coast as possible.

Questions were raised about the triple SSI area, woodland as well as the nesting bird's area. Also raised was the uncertainty that was badly affecting the health of some of our residents due to the length of time all this was taking.

The Officers informed the meeting that it was very unlikely to use the woodlands. The Officers were reminded that it was not just the Heights or Barton Estate that had to be dealt with in separate parts it was all parts of the Parish that had to be treat in the same way that makes up our village of Whippingham.

Questions were raised by the Council that it had requested copies of the legal opinion that had been quoted previously to them. The Officers agreed that it would be sent to the Parish Clerk who would put it on the Councils website for residents to read. The meeting was also informed that they were hoping for February 2020 for this to be completed but if they cannot get this area right they will not publish their plan then. It was agreed there would be a

The Officers were thanked for coming to the Council and answering question that had been put to them by our residents

Cllr Kirwood-Slack thanked everyone for coming and raising questions about the Coastal Path proposals and said the Council would keep in touch via our website.
